

N.B. applications for this round must relate to the social mobility aim which is the 2021 grant giving priority.

Grants of £5,000 - £50,000 will be awarded.



### **Fund restrictions**

- The Shoosmiths Community Investment Policy exclusions political parties or groups, religious organisations or personal appeals by, or on behalf of individuals.
- Applications are restricted to one application per charity.
- Applications must relate to a specific project.
- Applications are not permitted for unrestricted funding requests.
